**NOTICE TO ALL ARTISTS**

On behalf of the Sonny Boy Blues Society (SBBS) and Southern Bancorp, the Arkansas Delta Arts Partnership, Inc. (ADAP) is accepting submissions for the 2011 Arkansas Blues and Heritage Festival poster contest. The winning entry will be printed as a commemorative poster to publicize the 2011 festival. The artwork may also be used on T-shirts, post cards, or other festival souvenirs. All sales will go to SBBS, and the winner's original artwork remains the property of SBBS.

**JUDGING:** Three finalists will be selected from all entries. The final winner will be selected from the top three finalists. Contest finalists will be notified by letter.

**AWARD:** Winning artist will receive: \$800 and V.I.P. status during the 2011 festival.

**ENTRY DEADLINE: Friday, July 22, 2011**

**PICK UP:** The winning entry will remain the property of SBBS. All other artwork may be picked up at the Delta Cultural Center after the 2011 festival.

**UNVEILING & SIGNING:**

The winning entry will be unveiled on **Thursday, September 14, 2011**, at Southern Bancorp, 502 Cherry Street. The artist will be requested to sign commemorative posters at that time.

**EXHIBIT:** The top ten entries will be exhibited at the Delta Cultural Center during the 2011 festival.

**CONTEST GUIDELINES**

**THEME:** Theme should represent and be identifiable with blues music, musicians, and/or historical cultural elements of the area. No scrollwork, lettering, or numbers are acceptable on the face of the entry unless specifically relevant to the statement of the artwork.

**MEDIUM:** Any that conforms to theme and is rendered in full color.

**SIZE REQUIREMENTS:** Vertical drawing measuring 18"x24", any smaller or larger shall NOT be considered.

**PACKAGING:** Artwork should be matted and covered by a transparent film such as "shrink-wrap" or "acetate." No Glass. Artwork should be matted for easy removal, no permanent matting or dry mounting. **Overall thickness of artwork shall not exceed ½ inch. Mat should be 3" at top and sides, 5" at bottom.**

**ENTRY FEE:** Entry fee is \$20.00 per entry. You may enter as many times as you wish, but each entry must have the entry form and signed agreement. Entry fee is to be paid at the time of submission and is **non-refundable**. Checks should be made payable to the Arkansas Delta Arts Partnership, Inc. (ADAP).

**SUBMISSION:** Entries may be shipped or hand delivered, but must be accompanied by a completed entry form attached to the back of the artwork and a signed agreement. If shipped, shipping box should be heavy cardboard or comparable material suitable for shipping. **Entries that do not comply with guidelines will not be accepted.**
